Changing environmental conditions will affect the movement of composite board (MDF) and wood which is a natural, inherently variable material which will respond adversely to extreme environments (especially extremely low or high humidity conditions). Parts are assured of meeting moisture related specifications from time of shipment:
  - KAAT/JIT upon receipt.
  - Stock up to 5 days after being received in original packaging.Exposure to any extreme environmental conditions, including but not limited to extremely low or high humidity, shall immediately and completely void this Warranty.
  - \* Note \* Humidity control tolerances must be between 30 – 40%.
5. Specifications such as natural wood characteristics, sanding specs, drawings, tolerances, construction methods, and environmental conditions must be documented and mutually agreed upon.
6. Miter doors: Changing environmental conditions will affect the mitered joint, thus Woodcraft Industries, Inc., will not warranty any gap in the joint once exposed. Woodcraft Industries does warrant the strength of the joint at 800 pounds per square inch as measured by the standard pull test.
